The LIHD is complying with the Governor's Proclamation 20-25, which was extended through May 4th and a subsequent waiver to certain requirements of the OPMA. The latter remains in effect until April 23rd.

While the Board is allowed to conduct meetings, we are restricted to taking action on matters that are "necessary and routine or are matters necessary to respond to the COVID-19 outbreak and the current public health emergency." Important to note the term "action" includes discussion - meaning the intent of the Proclamation is that meetings be short, efficient, and restricted to necessary business. While routine is more self-explanatory (e.g. approval of minutes and vouchers), necessary items are those where any decision that if not taken prior to April 23, 2020 would have negative impacts on the District or the taxpayers.

The Finance Committee will provide an initial report on how discussions are coming along with UWNC in regard to their Fiscal Year 2021 Budget, as well as timing to receive the three-year Pro Forma that goes along with the 2021-2023 CSA renewal. The Committee has also asked for an assessment of the impact of COVID-19 on Clinic operations, as well as the recently reported move of staff to UW Medicine as of 1.1.2021.

In addition to providing a subsidy to UWNC, the District supports Lopez Island Physical Therapy. Unlike the Clinic, LIPT has closed operations as a result of COVID-19. Attached is an overview of the impact on LIPT's operations that contains a summary that was recently presented to the CWMA Board, as well as an update and request to the LIHD Board.

Finally, the Committee will review how the COVID-19 crisis could impact Property Tax receipts and the District's long-term financial outlook.
